



Ultimate Equine Experience – Competition Terms & Conditions

The 'Promoter' is New Zealand Thoroughbred Racing (NZTR).

Entry

These Competition Terms & Conditions ('the T&Cs') apply to the Ultimate Equine Experience competition ('the Promotion').

Entry is accepted via events.loveracing.nz/win by completing the entry form.

Entry can be completed online any time between **Tuesday 3 February and Tuesday 10 February 2026** ('the Promotion Period').

Entry into the Promotion is deemed to be acceptance of the T&Cs, and confirmation that the entrant has the necessary authority to enter the Promotion.

Entry to the Promotion is free and is open to New Zealand residents only. Ineligible Persons may not enter in the Promotion.

'Ineligible Persons' are:

- All NZTR employees and their Immediate Families;
- All people under the age of 18 years;
- 'Immediate Families' include spouses, de facto spouses, grandparents, parents, siblings, children, and grandchildren, whether by marriage, past marriages, remarriage, adoption, co-habitation or other family extension.

The Promoter reserves the right to exclude any person from participating in the Promotion on reasonable grounds.

The Promoter reserves the right to refuse to award any prize to an entrant who the Promoter decides (in its sole discretion) has violated the T&Cs, gained unfair advantage in participating in the Promotion, or won using fraudulent means.

By participating, entrants grant the Promoter exclusive permission to use their names, photographs, videos, and voices in connection with the Promotion and for future promotion and marketing purposes and waive any claims to royalty, right or remuneration for such use.

All entrant personal details must be valid and up to date and will be held by the Promoter and may be used for the purpose of the Promotion and for future promotion and marketing purposes in accordance with NZTR Privacy Policy (loveracing.nz/Privacy) unless otherwise directed by contestants at the time of entry.

Personal information provided at the time of entry is presumed to be true and, in the case of email – active, through to and beyond the date of the Promotion's completion.

Entry in the competition is deemed as consent by the entrants to be contacted by the Promoters post event via email or phone.

Winning the Prize

Only the person who originally entered the Promotion can be awarded the prize (the 'Winner'). The Winner will be determined in the manner set out in the T&Cs.

The Winner will be drawn by the Promoter on Wednesday 11 February 2026 from all entries received.

The Promoter's determination of the Winner and all decisions will be final, and no correspondence will be entered into.

The Winner will be notified via email or phone. Where attempts to contact the Winner fail (e.g. when the Winner cannot be contacted after three attempts) the Promoter will draw another winner.

The Prize is not redeemable for cash or transferable. No other family members, friends, work colleagues or any other person will be able to participate on the Winner's behalf. In the event that the Prize specified becomes unavailable for any reason the Promoter may substitute a prize of like or equal value.

The Winner takes the Prize entirely at their own risk and indemnifies the Promoter in respect of any claim for any accident, injury, property damage or loss of life that may occur in connection with the prize.

Entry in the competition is deemed as consent by the Winner to appear in a reasonable amount of advertising and publicity by the Promoter both on the day and for up to twelve months after the event.

The Promoter Responsibility

The Promoter reserves the right to amend, vary, extend, or discontinue a Promotion at any stage, for any reason.

Where the Prize is to be supplied by an entity outside the Promoter's control and that entity fails, for whatever reason, to supply the prize, the Promoter has no responsibility for the provision of the Prize and is not obliged to provide an alternative Prize or to take legal action to require the Prize supplier to provide the Prize.

Except for any liability that cannot be excluded by law, the Promotor (including its officers, directors, shareholders, employees, advisors, assignees, agents, licensees, representatives, advertising and promotional agencies), excludes all liability (including negligence), for any personal injury or any loss or damage (including loss of opportunity), whether direct, indirect, special or consequential, arising in any way out of the promotion or an entrant's participation in it, including, but not limited to, where attributable to any of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or notification by the Promoter being late, lost, altered, damaged or misdirected; (d) any variation in the prize; (e) any tax liability incurred by a claimant or entrant.
